

AN ORDINANCE AMENDING SECTION 206-62 OF THE MUNICIPAL CODE OF THE TOWNSHIP OF BRIDGEWATER ENTITLED “NO PARKING” AND SECTION 206-63 OF THE MUNICIPAL CODE OF THE TOWNSHIP OF BRIDGEWATER ENTITLED “NO PARKING AND PARKING CERTAIN HOURS; EXCEPTIONS” OF SO AS TO PROHIBIT PARKING IN CERTAIN AREAS AND AT CERTAIN TIMES ON THE MUNICIPAL COMPLEX PROPERTY

SECTION I. NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Bridgewater, in the County of Somerset that Section 206 (“Vehicles and Traffic”), Article XVII entitled “Parking and Traffic Flow Within Municipal Complex Areas” so as to restrict parking in the area around the Municipal Complex.

Section 206-62 is hereby amended as follows (struck through portions are to be removed; bolded and underlined portions are to be added):

206-62 No Parking

Kid Street	Both	All	110 feet from Planter to Garretson Road
Hanlon Drive	North	All, except Wednesday	Westerly from stop sign 500 feet to Commons Way
Hanlon Drive	South	All	Commons Way east 500 feet to stop sign
<u>Hanlon Drive</u>	<u>Both</u>	<u>All</u>	<u>Entire Length</u>

Section 206-63 is hereby amended as follows (struck through portions are to be removed; bolded and underlined portions are to be added):

206-63 No Parking and No Parking Certain Hours; Exceptions

Location	Hours	Exception
Municipal Annex, west <u>south</u> side	All	Police vehicles only
Municipal Building, front, Garretson Road	8:00 a.m. to 5:00 p.m.	Municipal business only
Municipal Building, west side, Garretson Road	8:00 a.m. to 5:00 p.m.	Municipal employees only
<u>Municipal Building,</u>	<u>7:00 a.m. to 2:30 p.m.</u>	<u>Municipal business only; student</u>

Location	Hours	Exception
<u>all parking lots</u>		<u>parking prohibited</u>

SECTION II. If any part of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of the ordinance.

SECTION III. Should any section, paragraph, sentence, or clause of this ordinance be declared unconstitutional or invalid for any reasons, the remaining portions of this ordinance shall not be affected thereby and shall remain in full force and effect and, to this end, the provisions of this ordinance are hereby declared severable.

SECTION IV. This ordinance shall take effect in the time and manner provided by law.
