AN ORDINANCE AMENDING CHAPTER 206, ENTITLED "VEHICLES AND TRAFFIC", SECTION 206-33 ENTITLED "SCHEDULE V: TRUCKS OVER FOUR TONS EXCLUDED" TO ADD CERTAIN RESIDENTIAL ROADWAYS TO THE LIST OF ROADWAYS THAT TRUCKS OVER FOUR TONS ARE NOT PERMITTED TO UTILIZE WITHIN THE TOWNSHIP OF BRIDGEWATER

WHEREAS, The Township of Bridgewater Municipal Code currently regulates which roadways that large vehicles or trailers are permitted to travel along; and

WHEREAS, the addition of Allen Road, Cross Road, Highland Avenue, Hillside Avenue, Long Road, Prospect Avenue, Somerset Avenue, and Wight Avenue to Section 206-33 is consistent with the Township Master Plan to minimize truck traffic in residential zones.

THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Bridgewater in the County of Somerset and State of New Jersey that Chapter 206, Section 206-33 of the Municipal Code of the Township of Bridgewater, County of Somerset, State of New Jersey be amended as follows (additions are written **thusly**):

Section I

Schedule V: Trucks Over Four Tons Excluded.

In accordance with § 206-10 of this chapter, trucks over four tons' gross weight are hereby excluded from the streets or parts of streets hereinbelow specified:

Somerset Avenue From Highland Avenue to Woodlawn Avenue

Thomas Street From Main Street to Central Avenue

Wharton Avenue From Main Street to Bridgewater Avenue

Wight Avenue From Somerset Avenue to N. Bridge Street

Woodrow Avenue From Ramsey Street easterly to Newberry Street

Yorktown Road From Union Avenue (New Jersey Route 28) to Jamestown Road

Section II

All ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

Section III

If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to this section, paragraph, subdivision, clause or provision and the remainder of this Ordinance shall be deemed valid and effective.

Section IV

This ordinance shall take effect upon adoption and publication in the manner required by New Jersey general law.
