AN ORDINANCE

OF THE CITY OF BRADFORD, COUNTY OF MCKEAN AND COMMONWEALTH OF PENNSYLVANIA, APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR THE SPECIFIC PURPOSES OF THE CITY GOVERNMENT AS HEREINAFTER SET FORTH, DURING THE YEAR 2024.

BE IT FURTHER ENACTED AND ORDAINED, AND IT IS HEREBY ENACTED AND ORDAINED, BY THE CITY COUNCIL OF THE CITY OF BRADFORD, MCKEAN COUNTY, PENNSYLVANIA.

SECTION I.

THAT FOR THE EXPENSES OF THE CITY OF BRADFORD FOR THE FISCAL YEAR 2024, THE FOLLOWING AMOUNTS ARE HEREBY APPROPRIATED FROM THE REVENUE AVAILABLE FOR THE YEAR FOR THE DEPARTMENTS, BUREAUS, AND SPECIFIC PURPOSES SET FORTH WITH THE EXCEPTION OF THE APPROPRIATIONS TO THE OFFICE OF ECONOMIC AND COMMUNITY DEVELOPMENT WHICH SHALL BE PAID EXCLUSIVELY FROM THE ADMINISTRATIVE REVENUES OF THAT OFFICE.

**SECTION IV.**


THIS ORDINANCE SHALL BE EFFECTIVE UPON FINAL PASSAGE.
