

**ORDINANCE NO: 2023 - 11**

**AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF BRISTOL,  
CHAPTER 205 ZONING AND THE BRISTOL TOWNSHIP ZONING MAP BY THE  
REZONING OF PARCELS 05-025-079 AND 05-029-100 TO C COMMERCIAL  
DISTRICT**

**WHEREAS**, the Council of the Township of Bristol is empowered to adopt Ordinances of the Township pursuant to the Pennsylvania First Class Township Code, 53 P.S. § 56502; and

**WHEREAS**, the Pennsylvania Municipalities Planning Code authorizes the Township of Bristol to amend its Zoning Ordinance and Zoning Map, 53 P.S. § 10609; and

**WHEREAS**, the properties identified as Tax Map Parcel Nos. 05-025-079 and 05-029-100 sit adjacent to the Pennsylvania Turnpike; and

**WHEREAS**, portions of these parcels would be proper locations for billboards along the Pennsylvania Turnpike and are otherwise undevelopable; and

**WHEREAS**, the Council of the Township of Bristol believes amendments to the Zoning Map, specifically rezoning ax Map Parcel Nos. 05-025-079 and 05-029-100 to the C Commercial Zoning District is necessary to protect the health, safety, morals and general welfare of the residents of the Township and is in accordance with the Township's Comprehensive Plan for future development.

**NOW, THEREFORE**, the Council of Bristol Township, Bucks County, Pennsylvania does hereby ordain and enact the following:

1. The Bristol Township Zoning Map, § 205-19, shall be amended by the rezoning of portions of Bucks County Tax Parcel Numbers 05-025-079 and 05-029-100 to the C Commercial District in accordance with the attached Exhibit.
2. The Township Engineer is directed to revise the Zoning Map of Bristol Township, as last revised, to incorporate the change in classification of the Property to C Commercial.
3. Whenever the requirements of this Ordinance are in conflict with other requirements of


the Ordinances of the Township of Bristol, the most restrictive or those imposing the higher standards, shall govern.


4. The provisions of this Ordinance are severable. If any section, clause, sentence, part or provisions hereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair any of the remaining sections, clauses, sentences, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Council of Bristol Township that this Ordinance would have been adopted if such illegal, invalid or unconstitutional section, clause, sentence, part or provision had not been included herein.
5. This Ordinance shall become effective immediately.


