Section I. Legislative Intent- It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Brutus pursuant to General Municipal Law §3-c, and to allow the Town of Brutus to adopt a budget for the fiscal year 2021 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

Section 2. Authority-The local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the town board.

Section 3. Tax Levy Limit Override- The Town Board of the Town of Brutus, County of Cayuga is hereby authorized to adopt a budget for the fiscal year 2020 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law §3-c.

Section 4. Severability- If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date- This local law shall take effect immediately upon filing with the Secretary of State.

<u>Public Hearing – Local Law # 1 of 2020 – Override the Tax Cap Levy for 2021 Budget</u>
Supervisor Hotaling opened the public hearing at 6:15 PM. Clerk Skellington communicated that a legal notice was placed in *The Citizen*, notice and law posted on the town's website, notice posted at village office, and on doors of town office. She read the law information to the group.

The total amount to be taxed including all special districts is currently below the tax cap levy limit of \$730,647. As a precaution, the board has decided to pass the local law to override the tax cap levy should it be necessary.
