

ORDINANCE NO. 24-03

**ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BRIDGETON AMENDING
SECTION 350 OF THE CITY CODE WITH RESPECT TO PROHIBITED PARKING
AND FINES FOR PARKING ORDINANCE VIOLATIONS**

WHEREAS, the City of Bridgeton has need to amend and revise the penalties listed in Section 350-4 (B) of the City Code for certain parking violations; and

WHEREAS, the City of Bridgeton is desirous of amending Section 350-13 to prohibit parking on certain portions of Irving Ave in response to an increasing number of vehicular accidents near a retail shopping plaza;

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Bridgeton that Section 350 of the City Code be amended and supplemented as follows:

Section 350-4 (B) Specific Fines shall hereafter be amended to read as follows:

<u>Violation</u>	<u>Penalty</u>
LO1 (§ 350-12A) Parking overtime	\$35
LO2 (§ 350-12B) All-night parking	\$35
LO3 (§ 350-18) Law Enforcement Vehicle Parking Zone	\$35
LO4 (§ 350-13F) Parking in prohibited area or no parking zone	\$35
LO5 (§ 350-20) Parking in taxi stand	\$35
LO6 (§ 350-13E) Parking on wrong side of street	\$35
LO7 (§ 350-19) Parking in bus stop	\$35
LO8 (§ 350-11B) No stopping or standing	\$35
LO9 (§ 350-11A) Obstructing traffic	\$45
LO10 (§ 350-8) Parking in private driveway	\$35
LO11 (§ 350-13A) Parking within 10 feet of a fire hydrant	\$45
LO12 (§ 350-13B) Parking within 25 feet of a crosswalk	\$35
LO13 (§ 350-13C) Parking within 50 feet of a stop sign	\$45
LO14 (§ 350-13D) Parking on sidewalk	\$35
LO15 (§ 350-14) Violation of time restrictions	\$35
LO16 (§ 350-38) Parking in handicapped zone	\$125

Section 350-4 (C) Enhanced Penalties is hereby repealed in its entirety

Section 350-13 (F) Prohibited Parking shall hereafter be amended and supplemented to read as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Irving Ave	South	From East Ave to a point 30 feet west therefrom
Irving Ave	South	From East Ave to a point 30 feet east therefrom
