

ORDINANCE # 1369

**AN ORDINANCE OF THE BOROUGH OF BRISTOL
COMMONWEALTH OF PENNSYLVANIA, FIXING THE
TAX RATE FOR THE 2024 FISCAL YEAR**

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of the Borough of Bristol, Commonwealth of Pennsylvania.

SECTION 1. That a tax be and the same is hereby levied on all property and persons within the said Borough subject to taxation for Borough purposes for the fiscal year of 2024 as follows:

Tax rate for general Borough purposes, on the sum of 35.00 mills on each dollar of assessed valuation.

Tax rate for street lighting, the sum of 4.85 mills on each dollar of assessed valuation.

Tax rate for special road fund, the sum of 2.42 mills on each dollar of assessed valuation.

Tax rate for maintaining and operating recreation places, the sum of 4.12 mills on each dollar of assessed valuation.

Tax rate for fire protection, the sum of 3.0 mills of each dollar of assessed valuation.

Tax rate for rescue service, the sum of 2.0 mills of each dollar of assessed valuation.

SECTION 2. All taxpayers subject to the payment of taxes assessed by this Ordinance shall be entitled to discount of two (2%) percent from the amount of such tax upon making payment of the entire amount thereof within two (2) months after date of the issuance of the tax notice therefore.

All taxpayers who shall fail to make payment of any of the taxes assessed against them by this Ordinance within four (4) months after the date of the tax notice shall be charged a penalty of ten (10%) percent which penalty shall be added to the taxes due by the tax collector and be collected by him as provided for in the Local Tax Collection Law, Act of May 25, 1945, P.L. 1050, Section 1, et seq., as amended.

SECTION 3. That any Ordinance or part of Ordinance conflicting with this Ordinance be and the same is hereby repealed insofar as the same affects this Ordinance.

ORDINANCE # 1370

**AN ORDINANCE IMPOSING ASSESSMENT
FOR THE REMOVAL OF GARBAGE AND REFUSE WITHIN
BRISTOL BOROUGH FOR THE YEAR 2024**

BE IT ORDAINED by the Council of the Borough of Bristol and it is hereby ordained by the authority thereof as follows:

1. A charge or assessment in the amount of Three Hundred Ninety Five Dollars (\$675.00) per year for each residence, residential unit and place of business situated in the Borough of Bristol, Bucks County, Pennsylvania is hereby imposed for the calendar year 2024.
2. Said dwellings and places of business in consideration of said payment shall receive the same service in the same manner as provided in the contract for refuse collection. The owners of any dwellings or places of business desiring service in excess of that provided for in said contract shall, with the authorization of the Borough Council, separately contract for same and the cost of said additional service, if any, shall be paid separately by persons desiring same.
3. The assessment herein imposed if not paid by December 31st shall be collected by the Borough Solicitor together with a penalty of ten (10%) percent as other matters payable to the Borough are collected, and non-payment shall entitle the Borough to file a municipal lien against the premises so served.
4. If any part of this Ordinance is declared unconstitutional by a Court having competent jurisdiction, the remaining part thereof shall remain in full force and effect, same being declared the legislative intent thereof.
5. All Ordinances and Resolutions inconsistent herewith are hereby repealed as to said inconsistency.
