RESOLUTION NO. 2024-14

**A RESOLUTION OF THE BOROUGH OF BRISTOL, BUCKS COUNTY, COMMONWEALTH OF PENNSYLVANIA; AUTHORIZING THE SUBMISSION OF A PA DEPARTMENT OF COMMUNITY & ECONOMIC DEVELOPMENT MULTI-PURPOSE COMMUNITY FACILITIES PROGRAM GRANT APPLICATION FOR DESIGN AND CONSTRUCTION OF A FIRE HALL COMMUNITY CENTER ON JEFFERSON AVENUE, AUTHORIZING THE PROPER OFFICERS OF THE BOROUGH TO SIGN SUCH APPLICATIONS AND TO SUBMIT SUCH APPLICATIONS AND INFORMATION AS MAY BE REQUIRED AND TO TAKE ALL SUCH OTHER ACTS AS MAY BE NECESSARY TO COMPLETE THE APPLICATION FOR FUNDING.**

**WHEREAS**, the Borough Council has determined that it is in the best interest of the Borough to seek PA Department of Community & Economic Development Multi-Purpose Community Facilities Program Grant funding to construct a new fire station with community center for the Bristol Fire Company, in order to consolidate the four (4) existing fire stations and to provide adequate emergency services for the community; and

**WHEREAS**, Borough Council desires to authorize the submission of such applications and material as may be necessary to apply for funding;

**NOW, THEREFORE**, the Borough Council of the Borough of Bristol does hereby RESOLVE as follows:

**SECTION I:**

1. Borough Council of the Borough of Bristol hereby authorizes the submission of an application for Multi-Purpose Community Facilities Program Grant funding in the amount of \$2,000,000.00 from the PA Department of Community & Economic Development to underwrite certain design and construction of a Fire Hall Community Center on Jefferson Avenue.
2. The proper officers of the Borough are duly authorized to submit such documents and applications as may be required to complete the required application for funding, and are further authorized to execute such applications and to take all such other actions as may be necessary to proceed with the application for funding authorized under this Resolution.

**SECTION II.**

This Resolution shall be effective immediately.
