**AN ORDINANCE AMENDING TITLE III OF THE CODE OF ORDINANCES OF THE CITY OF BRENTWOOD, MISSOURI, AND ESTABLISHING REVISED NO PARKING ZONE ON THE EAST SIDE OF DOROTHY AVENUE AT THE INTERSECTION WITH VAN MARK WAY.**

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRENTWOOD, MISSOURI, AS FOLLOWS:**

**SECTION 1.** Table III-A of Schedule III of Title III of the Code of Ordinances of the City of Brentwood, Missouri, is hereby amended by the addition of the following area where no parking is allowed at any time, to wit:

**Schedule III. No Parking At Any Time**

**Schedule III-A. No Parking At Any Time**

[In accordance with Section 355.010 of this Title, parking shall, on certain roads or streets or parts thereof, be prohibited as described in this Schedule: It shall be unlawful for any operator to stand, park or stop any vehicle at any time on or along the following described places within the City:]

[**NOTE:** No other locations listed in Schedule III-A are altered, amended, or affected in any way by this amendment and remain in full force and effect. For that reason, those locations are not set forth in full.]

Dorothy Avenue, the east side for a distance of thirty-five (35) feet north from its intersection with Van Mark Way and for a distance of thirty-five (35) feet south from its intersection with Van Mark Way.

**SECTION 2.** All ordinances and part of ordinances in conflict with this ordinance are, to the extent of such conflict, hereby repealed.

**SECTION 3.** The City Administrator and City Staff are hereby authorized and directed to perform all acts necessary to complete and enforce the parking revisions provided herein.

**SECTION 4.** This Ordinance shall be in full force and effect from and after its passage and approval according to law.
