AN ORDINANCE AMENDING TITLE IV. OF THE CODE OF ORDINANCES OF THE CITY OF BRENTWOOD, MISSOURI, AND ESTABLISHING REVISED NO PARKING EXCEPT BY PERMIT ZONES ON THE SOUTH SIDE OF PENDLETON AVENUE WEST OF BRAZEAU AVENUE, WEST SIDE OF BRAZEAU AVENUE, AND THE ALLEY WEST OF BRAZEAU AVENUE; PROVIDED HOWEVER THAT RESIDENTS AT THE PROPERTIES AT 2838, 2842, AND 2846 BRAZEAU SHALL ALSO BE ELIGIBLE FOR RESIDENT PERMITS FOR THE RESTRICTED AREA ON THE WEST SIDE OF THE 2800 BLOCK OF BRAZEAU AVENUE.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRENTWOOD, MISSOURI, AS FOLLOWS:

**SECTION 1.** Table IV-Q of Schedule IV of Title IV of the Code of Ordinances of the City of Brentwood, Missouri, is hereby amended by the addition of the following area where no parking is allowed at any time, to wit:

## Schedule IV. Parking Restricted At Certain Times

## Schedule IV-Q No Parking Except By Permit

[In accordance with Section 365.010 of this Title, the following streets or parts of streets are designated as zones where parking is prohibited except by resident permit. Only owners and lessees of residences directly adjacent to the restricted parking zones listed are eligible to receive permits for themselves and their visitors. To the extent that a restricted parking zone is limited to one (1) side of the street, only residents on that same side of the street shall be eligible to receive permits for themselves and their visitors: ]

**NOTE:** No other locations listed in Schedule IV-O are altered, amended, or affected in any way by this amendment and remain in full force and effect. For that reason, those locations are not set forth in full.]

Brazeau Avenue, the west side of 2801 through 2847 Brazeau Avenue and east side of the Brazeau Avenue alley to the west side of 2801 through 2847 Brazeau Avenue.

Brazeau Avenue, the west side of 2901 through 2925 Brazeau Avenue and east side of the Brazeau Avenue alley to the west side of 2901 through 2925 Brazeau Avenue.

## **BILL NO. 6498**

Pendleton Avenue, the south side of East Pendleton Avenue from the east side of the Brazeau Avenue alley eastwardly to the west line of 2901 Brazeau Avenue.

**SECTION 2.** All ordinances and part of ordinances in conflict with this ordinance are, to the extent of such conflict, hereby repealed.

**SECTION 3.** The City Administrator and City Staff are hereby authorized and directed to perform all acts necessary to complete and enforce the parking revisions provided herein.

**SECTION 4.** This Ordinance shall be in full force and effect from and after its passage and approval according to law.
