AN ORDINANCE AMENDING CHAPTER 225 OF THE BRENTWOOD CITY CODE RELATING TO ADDITIONAL RULES, REGULATIONS AND RESTRICTIONS FOR BRENTWOOD DAYS.

WHEREAS, the Mayor and Board of Aldermen wish to promote the health, safety and welfare of the citizens of the City of Brentwood by adding additional rules, regulations and restrictions for Brentwood Days; and

WHEREAS, this amendment to the Brentwood City Code was considered by the Public Works Committee and recommended for approval by the Board of Aldermen;

NOW, THEREFORE BE IT ORDAINED, by the Board of Aldermen of the City of Brentwood, Missouri, as follows:

SECTION 1: A new section, Section 225.060 of Chapter 225 of the Code of Ordinances of the City of Brentwood, Missouri, shall be inserted to read as follows:

CHAPTER 225	PARKS AND RECREATION
SECITON 225.060	ADDITIONAL RULES, REGULATIONS AND RESTRICTIONS FOR BRENTWOOD DAYS

- A. Restrictions. The following additional restrictions on activities and conduct in City parks are hereby established and/or authorized hereinafter provided during Brentwood Days in such park.
 1. All attendees bags may be subject to search by law enforcement or parks personnel at any time.
 2. No weapon, knife, firearm, projectile weapon, blackjack or other weapon capable of lethal use may be carried or displayed on the park grounds where Brentwood Days takes place.
 3. Private temporary shelters such as tents, large umbrellas, gazebos, dining canopies, etc., will not be allowed during Brentwood Days.
 4. It is unlawful for any person(s) to bring glass containers or coolers into Brentwood Days.


5. All persons are hereby prohibited from bringing animals of any type, with the exception of service animals or Police canine, into Brentwood Days. This includes pets on leashes or other restraints.
 6. It is unlawful for any person(s) to ride skateboards, roller blades, in-line skates, bicycles, scooters, motorized scooters, low speed vehicles or any other unauthorized motorized vehicles into Brentwood Days.
 7. Solicitation or distribution of handbills is not allowed except by an authorized vendor or sponsor participating in Brentwood Days.
 8. Fireworks and unmanned aerial vehicles, other than City unmanned aerial vehicles, or City-sponsored display, are not allowed in Brentwood Days.
 9. Any other restrictions deemed necessary by the City Administrator, Police Chief, Fire Chief or Director of Parks and Recreation shall be posted at the entry to Brentwood Days.
- B. Parking Restrictions. In accord with the provisions of Section 305.060 of this Code of Ordinances, parking restrictions on streets and thoroughfares will be in effect as deemed appropriate by the Fire Department, Police Department and Parks and Recreation Department and shown on signage posted at reasonable intervals and locations around Brentwood Days.
- C. Traffic Flow Patterns and Changes. In accord with the provisions of Section 305.060 of this Code of Ordinances, the Chief of Police may direct changes in traffic flow patterns, establish one-way streets, add, delete, or alter any traffic control device(s), restrict parking, control ingress and egress from all public streets, public or private parking lots or private roadways, or establish any other traffic control measures deemed necessary to assist in the traffic flow and to ensure emergency vehicle access in association with Brentwood Days.
- D. Parking Violations. The Brentwood Police Department is hereby authorized to tow and impound any vehicle(s) parked in violation of any restrictions established pursuant to this Section which, in the judgment of the officer in charge is reasonably likely to impede traffic, access to the park, Brentwood Days, or the safe and efficient passage of emergency vehicles. It will be the responsibility of the owner of any towed or impounded vehicle to pay for any tow or impoundment charges or fees.

SECTION 2: This Chapter, Article, Division and/or Section assignments designated in the Ordinance may be revised and altered by the codification company servicing the City's Code of Ordinances upon supplementation of such code if, in the discretion of the editor, an alternative designation would be more reasonable. In adjusting such designations, the editor may also change other designations, the editor may also change the designations and numerical assignment of code sections to accommodate such changes.

SECTION 3: It is hereby declared to be the intention of the Board of Aldermen that the sections, paragraphs, sentences, clauses, phrases and words of this ordinance are severable, and if any section, paragraph, sentence, clause, phrase or word(s) of this ordinance shall be declared unconstitutional or otherwise invalid, such unconstitutionality or invalidity shall not affect any of the remaining sections, paragraphs, sentences, clauses, phrases and words or this ordinance since the same would have been enacted by the Board of Aldermen without the incorporation in this ordinance of any such unconstitutional or invalid portion of the ordinance.

SECTION 4: This Ordinance shall be in full force and effect from and after the date of its passage and approval according to law.


