AN ORDINANCE ESTABLISHING THE RATE OF PROPERTY TAX TO BE LEVIED FOR THE YEAR 2024 FOR GENERAL MUNICIPAL PURPOSES; POLICE AND FIRE RETIREMENT FUND AND PUBLIC LIBRARY PURPOSES.

WHEREAS, state law requires the City to establish its tax rates and notify the County Collector of Revenue of the established rate by October 1; and

WHEREAS, in accord with the provisions of Section 137.073.5(4), RSMo. Supp. 2010, the Board of Aldermen hereby finds, declares and states, following a public hearing and at a public meeting, that the rate of tax for library purposes hereinafter established is justified by the necessity for maintaining the level of service Brentwood residents are entitled to expect from the City and the library and by the value the library provides to property owners in the City.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRENTWOOD, MISSOURI, AS FOLLOWS:


Section 1. General Fund: Residential Rate \$.000 – Commercial Rate \$.1830 – Personal Property Rate \$.2070 There is hereby levied upon all mixed, personal and real property within the limits of the City of Brentwood, taxable according to the laws of this State, a tax for general municipal purposes for the year 2024 in the amount of and at the rate of \$.000 per One Hundred Dollars (\$100.00) of assessed valuation for residential property, \$.1830 per One Hundred Dollars (\$100.00) of assessed valuation for commercial property and \$.2070 per One Hundred Dollars (\$100.00) of assessed valuation for personal property.

Section 2. Police and Firemen’s Retirement Fund: Residential Rate \$.2660 – Commercial Rate \$.3510– Personal Property Rate \$.3850 There is hereby levied upon all mixed, personal and real property within the limits of the City of Brentwood, taxable according to the laws of this State, a special tax for the purpose of providing the annual contribution of the City to the Police and Firemen’s Retirement Fund for the year 2024 in the amount of and at the rate of \$.2660 per One Hundred Dollars (\$100.00) of assessed valuation for residential property, \$.3510 per One Hundred Dollars (\$100.00) of assessed valuation for commercial property and \$.3850 per One Hundred Dollars (\$100.00) of assessed valuation for personal property.

Section 3. Public Library: Residential Rate \$.4220 – Commercial Rate \$.4670 – Personal Property Rate \$.5100 There is hereby levied upon all mixed, personal and real property within the limits of the City of Brentwood, taxable according to the laws of this State, a special Library Fund Tax for the establishment and maintenance of free public library in said City for the year 2024 in the amount of and at the rate of \$.4220 per One Hundred Dollars (\$100.00) of assessed valuation for residential property, \$.4670 per One Hundred Dollars (\$100.00) of assessed valuation for commercial property and \$.5100 per One Hundred Dollars of assessed valuation for personal property.

Section 4. This ordinance shall be in full force and effect from and after the date of its passage and approval according to law.


