AN ORDINANCE REPEALING ORDINANCE 22-49 AND ADOPTING A NEW ORDINANCE FIXING THE SALARIES OF CERTAIN SPECIAL SERVICE AND SALARIED EMPLOYEES, AS DENOTED IN THE CITY CHARTER FOR FISCAL YEAR 2024

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRIDGETON, MISSOURI, AS FOLLOWS:

Section 1 Ordinance No 22-49 is hereby repealed.

Section 2 **APPOINTED EMPLOYEE SALARIES FOR FISCAL YEAR 2024**

The following employees are appointed in accordance with Section 3.09, 4.04, 5.03 and 5.04 of the City Charter. Their salaries are established as follows:

City Clerk	\$ 91,114.00	per year
Court Clerk	\$ 64,572.00	per year
Administrative Assistant	\$153,933.00	per year
City Engineer	\$139,482.00	per year
Chief of Police	\$129,251.00	per year

Section 3 The positions listed in Section 2 are entitled to all employee benefits on the same basis as those provided to classified employees of the City.

Section 4 A salary range is hereby established for the following appointed employee positions:

City Clerk	\$ 78,725.00 - \$103,740.00
Court Clerk	\$ 50,978.00 - \$ 71,616.00
Administrative Assistant	\$123,901.00 - \$171,600.00
City Engineer	\$ 99,289.00 - \$139,482.00
Chief of Police	\$105,384.00 - \$149,653.00

Section 5 **APPOINTED PART-TIME HOURLY AND SALARIED POSITIONS**

The following positions are appointed in accordance with Section 5.02 of the City Charter. Those hourly wage and annual salary is established as follows:

City Attorney	\$350.00	per hour
Prosecuting Attorney	\$25,000.00	per year


