ORDINANCE NO. 2023-215

AN ORDINANCE TO PARTIALLY AMEND ORDINANCE SECTION 470-54(C), ESTABLISHING STREET RIGHT-OF-WAY WIDTHS, TO ALLOW PLANNED UNIT DEVELOPMENTS TO SUBMIT STREET DESIGN PLANS TO THE CITY ENGINEER AND FIRE CHIEF FOR APPROVAL IN ANY PLANNED UNIT DEVELOPMENT.

THE CITY OF BRIDGMAN ORDAINS:

Section 1. Section 470-54(C) is hereby partially amended to add the following highlighted language:

[Existing language:

C. Right-of-way widths. All public streets shall be designed and developed in accordance with the standards set forth in the following table, Minimum Standards for Street and Roadway Design, except as detailed in this Section:

Street:	Right-of-Way Width (feet)	Pavement Width to Edge of Pavement (feet)	Street Width to Back of Curb (feet)	Radius of Horizontal Curves (feet)	Max. Gradient (percent)	Min. Gradient (percent)	Clear Minimum Sight Distance (feet)
Local, including cul-de-sac ¹	66	32	36	150	7%	0.4	200

Rolled curbs may be permitted except at intersections having full-height curb construction.]

<u>Roads designed in a Planned Unit Development submitted to the Planning</u> <u>Commission and City Council under the Bridgman City Zoning Ordinance</u> <u>may vary from the Minimum Standards for Street and Roadway Design shown</u> <u>above if both of the following requirements are met:</u>

1. <u>The proposed road design is reviewed and approved in writing by the City</u> <u>Engineer; and</u> 2. <u>The proposed road design is reviewed and approved by the Bridgman Fire</u> <u>Chief, with consideration given to providing full and complete access to</u> <u>public safety vehicles, including fire trucks.</u>

This Ordinance shall become effective fifteen (15) days after publication.
