ORDINANCE AUTHORIZING ACCEPTANCE AND EXECUTION OF TEMPORARY CONSTRUCTION EASEMENTS AND SANITARY SEWER EASEMENTS FOR METER CHAMBER 9B SANITARY SEWER COLLECTION SYSTEM UPGRADES PROJECT

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Branchburg, County of Somerset, State of New Jersey, as follows: (1) the Temporary Construction Easements and Sanitary Sewer Easements referenced herein and on file with the Township Clerk are hereby accepted and approved; (2) the Mayor and Clerk are authorized to execute these Easements on behalf of the Township; (3) the Township Clerk is authorized to record the Easements with the Somerset County Clerk; and (4) this Ordinance shall take effect upon its adoption, passage and publication according to law.
