# ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF BURLINGTON ENTITLED "ADMINISTRATIVE CODE OF THE TOWNSHIP OF BURLINGTON", MORE SPECIFICALLY, SECTION 20-65 SALARIES (SCHEDULE D SALARY UPDATES FOR 2024 POLICE DEPARTMENT)

**BE IT ORDAINED AND ENACTED** by the Township Council of the Township of Burlington, County of Burlington and State of New Jersey, that

**Section 1.** Section 20-65 entitled "Salary Schedules" of the General Ordinances of the Township of Burlington is hereby amended to provide as follows:

<u>Section 2.</u> Section 20-65 <u>ADOPTION</u>. The annual and hourly salary ranges for the officials and certain employees of the Township of Burlington as shown below are hereby adopted to be effective as stated at top of applicable column or next to each title. Said salaries are to be paid every week on Friday, except for the officials and employees listed on Schedule A, who shall be paid annually.

**POLICE OFFICER** (assigned as Detective, Community Resource Officer and School Resource Officer):

All police officers assigned as a CRO or SRO shall receive an annual salary adjustment of 2.5% of base salary or \$1,500.00 whichever is higher. Police Officers assigned to the Detective Division shall receive an annual stipend of 2.5% of base salary plus \$1,000.00. The Detective Sgt. Shall receive an annual stipend of \$2,500.00.

# POLICE OFFICER WITH EMT CERTIFICATION

Effective January 1, 2011 those Police Officers who have achieved Certified EMT status shall receive an annual salary adjustment of nine hundred (\$900.00) dollars to be included in their base salary.

## SERGEANT, LIEUTENANT WITH EMT CERTIFICATION

Effective January 1, 2011 those Sergeants and Lieutenants who have achieved Certified EMT status shall receive an annual salary adjustment of nine hundred (\$900.00) dollars to be included in their base salary.

<u>Section 3</u>. This Ordinance shall only affect those Officials and Employees salaries specifically delineated herein, and any Offices or Employees not mentioned shall be paid pursuant to existing provisions of Section 20-65 of the Ordinance of Burlington Township.

All remaining other provisions of Section 20-65 of the Ordinances of Burlington Township shall remain in full force and effect.

**Section 4.** This Ordinance Shall be effective from January 1, 2024.

This Ordinance was introduced at a meeting of the Township Council in the Township of Burlington held on November 13, 2023, and will be considered for final passage after a public hearing held at a Regular Meeting of the Township Council to be held on November 28, 2023, at the Township Municipal Building, Burlington Township, New Jersey at 7:00 p.m.

This will certify that the foregoing Ordinance was passed by a majority of the Burlington Township Council on November 28, 2023.
