An Ordinance to amend the Buchanan Charter Township Zoning Ordinance regarding Essential Services, and to repeal all ordinances or parts of ordinances in conflict herewith and to establish the effective date of said Ordinance.

ORDAINS:
SECTION I
AMENDMENT OF CHAPTER 2
SECTION 2.02 DEFINITIONS E.

Section 2.02 E. is hereby amended as follows:

#### **ESSENTIAL SERVICES:**

The erection, construction, alteration or maintenance by public or quasi-public utilities or municipal departments or Township-certified cable television companies of underground, surface or overhead gas, steam, electrical, fuel or water systems for the purposes of transmission, distribution, collection, communication, supply, or disposal; including towers, poles, wires, mains, drains, sewers, pipes, conduits, cables, fire alarm and police call boxes, traffic signals, hydrants and similar equipment, which are necessary for the furnishing of adequate service by such utilities or municipal departments for the general health, safety, and welfare of the public. Essential services shall not include storage yards, sales or business offices, or commercial buildings or activities.

# SECTION II SEVERABILITY

Should any provision or part thereof, within the Zoning Ordinance be declared by any court or competent jurisdiction to be invalid or unenforceable, the same shall not affect the enforceability of the balance of this Ordinance which shall remain in full force and effect.

### SECTION III REPEAL

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

## SECTION XIV EFFECTIVE DATE

This Ordinance shall take effect eight days following publication after adoption.
