

**TOWNSHIP OF BYRAM

ORDINANCE NO. 009 - 2019**

**AN ORDINANCE TO AUTHORIZE A CAPITAL EXPENDITURE FOR THE
IMPROVEMENT OF WHITEHALL HILL ROAD IN AND BY THE TOWNSHIP
AND TO PROVIDE FUNDING IN THE AMOUNT NOT TO EXCEED \$87,000.00**

Purpose Statement: Reconstruction and Resurfacing of Whitehall Hill Road in and by the Township including reconstruction of culverts and headwalls and all curbing, drainage facilities, landscaping, reclamation, milling, structures, roadway surfaces including oil and stone or similar application, materials, equipment, site work and engineering costs.

WHEREAS, the Township of Byram is planning to complete improvements of Whitehall Hill Road; and

WHEREAS, these improvements may include reconstruction of culverts and headwalls and all curbing, drainage facilities, landscaping, reclamation, milling, structures, roadway surfaces including oil and stone or similar application all materials, equipment, site work and engineering; and

WHEREAS, the 2019 Municipal Budget included \$100,000 as a Capital Improvement Appropriation as a Supplement to the Road Improvement Program and \$208,000 for 2019 Municipal Aid Program (NJDOT Grant); and

WHEREAS, the total cost for this project amount to \$295,000.00, \$208,000 to be funded from the 2019 Municipal Aid Program (NJDOT Grant), \$87,000 to be funded as stipulated below.

NOW, THEREFORE BE IT ORDAINED and enacted by the Council of the Township of Byram, County of Sussex, and State of New Jersey, as follows:

Section 1 – The Manager and Municipal Clerk are authorized to execute road improvements as set forth in plans prepared by the Municipal Engineer. All actions shall be taken in accordance with the Local Public Contracts Law and other applicable regulations.

Section 2 – This ordinance shall be funded as follows:

\$40,000.00	Capital Fund – Reserve for Road Resurfacing
\$47,000.00	Capital Fund Balance

Section 3 – This Ordinance shall take effect twenty (20) days after final adoption and publication as required by law.
