ORDINANCE NO: 010 - 2024

AN ORDINANCE OF THE COUNCIL OF THE TOWNSHIP OF BYRAM TO VACATE, RELEASE AND EXTINGUISH ANY PUBLIC RIGHTS IN PORTIONS OF THE STREETS AND ROADWAYS KNOWN AS DEER TRAIL AND PARTRIDGE ROAD PURSUANT TO <u>N.J.S.A. 40:49-6</u> AND <u>N.J.S.A. 40:67-21</u>

Purpose Statement: The purpose of this Ordinance is to vacate portions of the streets known as Deer Trail and Partridge Road and identified herein pursuant to <u>N.J.S.A.</u> 40:49-6 and <u>N.J.S.A.</u> 40:67-21.

WHEREAS, it was found and determined by the Township Council of the Township of Byram that portions of the streets and roadways known as Deer Trail and Partridge Road are not needed for public use, and

WHEREAS, the Byram Planning Board adopted a Memorializing Resolution dated February 16, 2024, in case Z26-2023 for minor subdivision approval recommending these road vacations to create a better layout for both the lots and the Township Right-of-Way; and

WHEREAS, the Township Council of the Township of Byram hereby intends to vacate, release and extinguish portions of Deer Trail and Partridge Road as described herein and in the attached Schedule A, and

WHEREAS, the Mayor has recused on this Ordinance because the Ordinance relates to the Mayor's real property.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Byram as follows:

Section 1. Portions of Streets to Be Vacated. Any public rights as to the right-of-way of the following portions of Deer Trail and Partridge Road are hereby vacated except for all rights and privileges presently possessed by Public Utilities, as defined in R.S. 48:2-13, and any Cable Television Company as defined in the Cable Television Act, P.L. 1972, c. 186 (c.48:5A-1, et seq.), to maintain, repair and replace their existing facilities in, adjacent to, over or under the said area to be vacated:

THAT THE PORTIONS OF Deer Trail and Partridge Road in the Township of Byram that are hereby vacated are described by metes and bounds descriptions in attached Schedule A.

Section 2. Notice. After being introduced and having passed a first reading, this ordinance shall be published at least once not less than ten (10) days prior to the time fixed for further consideration for final passage.

At least ten (10) days prior to the time fixed for further consideration of this ordinance for final passage, a copy thereof, together with notice of its introduction and the time and place when and where the ordinance will be further considered for final passage, shall be mailed to the owner of Block 237, Lot 317 and to every person whose lands may be affected hereby so far as may be ascertained. The Township Clerk shall mail said notices in accordance with N.J.S.A. 40:49-6.

Within sixty (60) days of the effective date of this Ordinance the Township Clerk shall file a copy, certified by her under seal of the Township to be a true copy, together with proof of publication thereof, in the Office of the Sussex County Clerk in accordance with <u>N.J.S.A.</u> 40:67-21.

Section 3. Severability. If any part of this Ordinance is for any reason held to be invalid such decision shall not affect the validity of the remaining portion of the Ordinance. Any ordinance or portion thereof that may be inconsistent with the ordinance is hereby repealed to the extent of the inconsistency.

Section 4. Repealer.

All existing Ordinances and/or parts thereof which are inconsistent with the terms of this Ordinance are, to the extent of such inconsistency, repealed.

Section 5. Effective Date. This Ordinance shall take effect twenty (20) days after adoption and publication as prescribed by law.
