ORDINANCE NO. 2469

AN ORDINANCE AMENDING THE CODE OF THE BOROUGH OF CARLISLE TO REMOVE ONE ON-STREET HANDICAP PARKING SPACE ON SOUTH HANOVER STREET.

IT IS HEREBY ENACTED AND ORDAINED by the Borough Council of the Borough of Carlisle, Cumberland County, Pennsylvania, as follows:

SECTION 1: Section 244-100 [Schedule XVIII: Special-Purpose Parking Zones) of Article XI [Schedules) of Chapter 244 [Vehicles and Traffic] of the Code of the Borough of Carlisle is hereby amended as follows:

A. The following is hereby added by insertion in proper alphabetical sequence:

REMOVE:

<u>Name of Street</u>	<u>Side</u>	<u>Authorized Purpose or Vehicle</u>	<u>Location</u>
S Hanover Street	West	Handicap Parking Only	From a point 39 feet North of Walnut St. to a point 59 feet North of Walnut St.

SECTION 2: In all other respects, Chapter 244 [Vehicles and Traffic] of the Code of the Borough of Carlisle shall remain as heretofore enacted, ordained and amended, which said Chapter, as amended, is hereby re-enacted in its entirety herein.

SECTION 3: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
