LOCAL LAW NO. 3 FOR THE YEAR 2022

A LOCAL LAW REPEALING LOCAL LAW NO. 7 FOR THE YEAR 2017,

Be it enacted by the Cayuga County Legislature of the County of Cayuga, as follows:

Section I. Repealed.

LOCAL LAW NO. 7 FOR THE YEAR 2017, “A LOCAL LAW REPEALING LOCAL LAW NO. 1 OF 2010 AND ESTABLISHING THE OFFICE OF COUNTY ADMINISTRATOR FOR CAYUGA COUNTY”, is hereby REPEALED.

Section 2. CONFLICT WITH PREVIOUS LOCAL LAWS OR RESOLUTIONS

In the event of a conflict or inconsistency between this Local Law and any previous Local Law or Resolution of the County Legislature, the terms of this Local Law shall govern. Local Law 1 for the year 2010 is hereby repealed. Local Law No. 1 for the year 2006 is hereby repealed.

Section 3. EFFECTIVE DATE

This Local Law shall take effect when all applicable statutory requirements for its passage and adoption have been complied with fully and it has been duly filed as provided by the Municipal Home Rule law.
