LOCAL LAW NO. 7 FOR THE YEAR 2023

A LOCAL LAW PROVIDING SALARY INCREASES FOR CERTAIN COUNTY OFFICIAL APPOINTED FOR A FIXED TERM, DURING THEIR TERM.

BE IT ENACTED by the County Legislature of the County of Cayuga, as follows:

Section 1. Due to the challenges surrounding the recruitment and hiring of additional finance staff within County Government, the Director of Finance has assumed duties over and above her usual duties as Finance Director. This has resulted in the Director of Finance expending a significant amount of time to perform these duties in addition to her regular scheduled hours. The County Legislature finds that it is equitable and just and in the public interest to compensate the Director of Finance for these additional duties. It is the intent hereof to provide comparable compensation for the Director of Finance during the remainder of her term of Office, in accordance with Section 201 of County Law.

Section 2. Effective October 1, 2023, the salary schedule for the Director of Finance shall be as follows: the salary schedule for the following fixed-term positions shall be as follows:
