LOCAL LAW NO. 8 FOR THE YEAR 2023

A LOCAL LAW AUTHORIZING THE SALE OF COUNTY PROPERTY LOCATED AT OLD STATE RD, TAX MAP NO. 4.00-1-1.5 AND 4.00-1-40 TO PAUL G. KELLEY AND JOAN E. KELLEY, TRUSTEES, OR THEIR SUSCCESSORS IN TRUST, UNDER THE KELLEY LIVING TRUST

BE IT ENACTED BY THE COUNTY LEGISLATURE OF THE COUNTY OF CAYUGA, AS FOLLOWS:

Section 1. Findings. The County of Cayuga is the owner of a 0.8 acre \pm and a 1.5 acre \pm parcel of vacant land located at Old State Rd in the Town of Sterling and bearing tax map nos. 4.00-1-1.5 and 4.00-1-40 (Property). Adjoining property owner Paul Kelley, Trustee for the Kelley Living Trust, has expressed an interest in purchasing said Property for a consideration of \$4,000.00.; and such consideration is in excess of assessment values for residual land. The Property is not needed for County purposes.

Section 2. Environmental Review. An analysis of the potential environmental impacts, if any, has been done under the State Environmental Quality Review Act (SEQRA) and, as lead agency, the County hereby determines that the proposed action is an Unlisted Action under SEQRA and a Short Environmental Assessment Form has been prepared. The Short Environmental Assessment Form filed withthis Legislature is satisfactory with respect to scope and content and adequacy in compliance with SEQRA is hereby accepted by the County. Cayuga County Legislature does hereby make and adopt a Negative Declaration for the project and has determined that the proposed action will not have a significant effect on the environment. The Chair of the Cayuga County Legislature, or his designee, is authorized to take such action to comply with the requirements of SEQRA, including without limitation, the execution of documentation and filing of same and any other actions to implement the intent of this local law.

Section 3. Sale Authorized. The Chair of the Cayuga County Legislature is hereby authorized to transfer to Paul G. Kelley and Joan E. Kelley, Trustees, or their successors in trust, under the Kelley Living Trust said Property for a consideration of \$4,000.00. The Chair of the Cayuga County Legislature is hereby authorized to execute agreements to further the intent of this local law.

Section 4. Effective Date. This local law shall be filed and take effect in accordance with provisions of the Municipal Home Rule Law and is subject to a permissive referendum.
