BE IT ENACTED by the Cayuga County Legislature of the County of Cayuga as follows:

Section 1. Local Law No. 3 of the year 1994 entitled "A Local Law Imposing A Tax On The Occupancy Of Hotel Rooms Pursuant To Chapter 533 Of The Laws Of 1994 Of The State Of New York" is hereby amended to add a new Section 8, and amending Local Law No. 2 for 2021, Local Law No. 2 of 2018, Local Law No. 1 of 2015, Local Law No. 1 of 2012, Local Law No. 1 of 2009 entitled "A Local Law Amending Local Law No. 5 of 2007 to Increase the Rate of the Hotel/Motel Room Tax to Five Percent (5%) in Cayuga County", and also Authorize Cayuga County to Use All or Part of the Money in the Special Fund to Pay a Single Not-For-Profit Corporation to Promote Tourism and Convention Development in the County is hereby amended to add a new Section 4, as follows:

Section 8. Continuing Hotel Room Tax for Three Years.

The tax imposed by this Local Law is hereby continued, authorized and enacted for an additional period of three (3) years, beginning September 20, 2024, and ending on September 21, 2027.

Section 4. Continuing Hotel Room Tax for Three Years.

The tax imposed by this Local Law is hereby continued, authorized and enacted for an additional period of three (3) years, beginning September 20, 2024, and ending on September 21, 2027.

Section 2. Said A LOCAL LAW AMENDING LOCAL LAW NO. 2 FOR 2021, A LOCAL LAW AMENDING LOCAL LAW 2 OF 2018, Local Law No. 1 of 2015, Local Law No. 1 of 2012, Local Law No. 1 of the year 2009, and Local Law No. 5 of 2007, and Local Law No. 3 of the year 1994, shall remain unchanged in all other respects and are hereby so ratified.


