A LOCAL LAW PROVIDING FOR SALARY INCREASES FOR CERTAIN COUNTY OFFICERS APPOINTED FOR A FIXED TERM, DURING THEIR TERM.

BE IT ENACTED by the County Legislature of the County of Cayuga, as follows:

Section 1. It is the intent hereof to provide increases for certain County Officers appointed for a fixed term, during their term of office, in accordance with § 201 of County Law.

Section 2. Effective January 1, 2024, the salary schedule for the following fixed-term offices shall be as follows:
