

**AN ORDINANCE AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A LEASE AGREEMENT WITH BOWMAN'S SOLUTIONS FOR LEASE OF A POSTAGE METER**

**WHEREAS**, our current lease agreement with Bowman's Solutions is set to expire January 20, 2021; and

**WHEREAS**, Bowman's Solutions is offering an upgraded postage meter machine at a lower monthly rate than our previous lease agreement.

**BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CAMDENTON, MISSOURI, AS FOLLOWS:**



Section 2. All Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section 3. This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approval by the Mayor.
