# AN ORDINANCE OF THE TOWN OF CARROLLTON, MISSOURI ACCEPTING THE RESULTS OF THE APRIL 2nd, 2024 ELECTION.

WHEREAS, notice of the election was given by the election authority in accordance with the statues of the State of Missouri and the Ordinances of the Town of Carrollton, Missouri, and such notice published did specify the date and time of the election and a sample ballot; and

WHEREAS, the election results have been certified by Petal Stanley, the Carroll County Clerk;

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF CARROLLTON, MISSOURI AS FOLLOWS:

Section 1. It is hereby found and determined that the results of the election held on April 2, 2024, are as follows:

#### PROPOSITION 1

Shall the Town of Carrollton, Missouri, issue its sewerage system revenue bonds in the amount of \$ 15,000,000.00 for the purpose of extending and improving the Town's sewerage system, including acquiring land and rights of way, the cost of operation and maintenance of said sewerage system and the principal of and interest on said revenue bonds to be payable solely from the revenues derived by the Town from the operation of its sewerage system, including all future improvements and extensions thereto ?

#### PROPOSITION 2

Shall the Town of Carrollton, Missouri, impose a sales tax of three percent (3%) on all retail sales of adult use marijuana sold in the Town of Carrollton, Missouri? The Tax, if approved, does not apply to marijuana purchased for medical use.

Section 2. It is hereby found that said election was duly held and conducted in conformity with the constitution and statutes of the State of Missouri, and in all respects regular and valid and that a majority of the qualified voters on the candidates voted that Lisa Conner is declared elected to a two (2) year term as Councilperson Ward III, that Keith Higgins is declared elected to a two (2) year term as Councilperson Ward I, Jacob Reffitt is declared elected to a two (2) year term as Council at Large, Susan Bliss Withdraws.

It is hereby found that said election was duly held and conducted in conformity with the constitution and statutes of the State of Missouri, and in all respects regular and valid and that a majority of the qualified voters on the proposition at said election voted for the proposition. The vote on the sales tax on marijuana retail use authorized by Mo constitution article XIV, section 2.6 (5). There is no expiration date on this tax. This tax shall become effective the first day of the second calendar quarter following Department of Revenue notification.

The Town Clerk shall forward to the Director of Revenue of the State of Missouri by United Stated certified mail (1) a certified copy of this Ordinance, (2) a copy of the abstract of the votes cast on the proposition at the election and (3) a map clearly showing the boundaries of the Town.

Section 3. All ordinances or parts of ordinances in conflict herewith are to the extent of such conflict, hereby repealed.

Section 4. If any clause, word, paragraph, section or other part or portion of this ordinance is held to be invalid, illegal, unlawful, or unconstitutional for any reason, the Town Council hereby declares it would nevertheless have enacted the remaining portions thereof, and such remaining portions shall remain in full force and effect.

Section 5. This ordinance shall be in full force and effect from and after its passage and approval.
