ORDINANCE NO. 2024-1496

**AN ORDINANCE ACCEPTING A BID AND AGREEMENT TO SELL TO New Hampton Rural Fire Protection District A 1996 PIERCE PUMPER TRUCK OWNED BY THE TOWN AND AUTHORIZING ALL ACTS NECESSARY TO CARRY OUT THE TERMS OF SUCH AGREEMENT.**

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF CARROLLTON as follows:

**Section 1:** The Council accepts the bid of New Hampton Rural Fire Protection District as the highest and best bid for the purchase of a 1996 Pierce Pumper Truck owned by the Town and authorizes the Town to enter into a Sales Agreement for the Sale of such Truck on an AS IS basis for a sale price of \$57,350. The terms and provisions of the Agreement are hereby approved and adopted by the Council of the Town of Carrollton, Missouri, on behalf of said Town.

**Section 2:** The Council authorizes and directs the Mayor of the Town of Carrollton, Missouri to execute the Agreement and any documents the Mayor deems necessary or proper to carry out fully the terms of such Agreement. The Mayor, with the advice of the attorney acting for the Town, may make minor corrections and changes to the Agreement that does not affect the substance of the Agreement.

**Section 3:** The portions of this Ordinance shall be severable. In the event that any portion of this Ordinance is found by a court of competent jurisdiction to be invalid, the remaining portions of this Ordinance are valid, unless the court finds the valid portions of this Ordinance are so essential and inseparably connected with and dependent upon the void portion that it cannot be presumed that the Town Council would have enacted the valid portions without the invalid one, or unless the court finds that the valid portions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.

**Section 4:** This ordinance amends any prior ordinance or parts of any prior ordinance that might be in conflict herewith, including without limitation any ordinance requiring any other method for the purchase of such property.


**Section 5:** This ordinance shall be in full force and effect from and after the date of its passage and approval.
