**AMENDED ORDINANCE, CODE OF CARROLL TOWNSHIP
§81-11.**

AN ORDINANCE AMENDING CARROLL TOWNSHIP ORDINANCE 2019-243, NOW KNOWN AS THE CODE OF CARROLL TOWNSHIP §81. ET AL., AS THEREAFTER AMENDED. SPECIFICALLY, CARROLL TOWNSHIP IS AMENDING THE CODE OF CARROLL TOWNSHIP §81-11. TO PROVIDE FOR THE REGULATION COMPENSATION FOR TAX COLLECTOR REAL PROPERTY AND FIRE TAX ASSESSMENT.

Background

The background of amending the Code related to the Tax Collector real property assessment rate, is that the Carroll Township implemented the Fire Tax in 2023. The increase in the rate of compensation coincides with the increase in work. The Board of Supervisors (“Board”) recognizes these facts and is amending the Code of Carroll Township as follows:

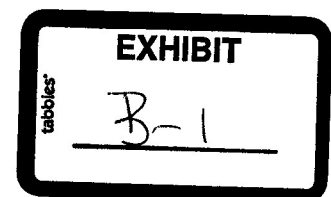
IT IS HEREBY ENACTED AND ORDAINED by the Board of Supervisors of Carroll Township, York County, Pennsylvania, as follows:

1. Amendment. The Code of Carroll Township, Chapter 81, §81-11 shall be replaced in its entirety by the language below, as follows:

§81-11: Real property and Fire tax assessment.

Carroll Township levies an annual tax assessment upon all real property and fire tax within the Township that is subject to the real property tax and fire tax. The Tax Collector is charged with the collection of the real property and fire tax assessment and shall be compensated in the amount of \$1.00 per assessment bill mailed, and \$3.50 per assessment bill collected. The Township shall reimburse the Tax Collector upon submission of proper voucher for the Tax Collector’s actual expenditures for printing, postage, and other expenses allowable by law as required to perform his or her duties. The Township shall pay the premium cost of any fidelity bond required by the Tax Collector for the performance of duties to or for Carroll Township.

2. All Other Respects. §81, et al., of the Code of Carroll Township shall remain as heretofore enacted, ordained, and amended, which said Article, as amended, in hereby re-enacted in its entirety herein.
3. Severability. If any of the provisions of this Ordinance shall be held to be determined unconstitutional, illegal, or otherwise invalid, that decision shall not affect the remaining provisions of this Ordinance or any other provision, section, article, or chapter of the Ordinances of Carroll Township.



4. Repealer. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
5. Effective Date. This Amendment of Compensation shall go into effect upon the swearing in of the Tax Collector (January 2026), after the November 2025 Municipal Election.
