

ORDINANCE NO. 01 - 2021

AN ORDINANCE OF THE TOWNSHIP OF CECIL, WASHINGTON COUNTY, PENNSYLVANIA, AMENDING VESTING PROVISIONS OF THE NONUNIFORMED EMPLOYEES PENSION PLAN, ADOPTED DECEMBER 30, 1992 BY ORDINANCE NUMBER 9-92, AS AMENDED BY RESOLUTION NUMBER 26-01.

BE IT ORDAINED AND ENACTED by the Board of Supervisors of Cecil Township, Washington County, Pennsylvania, pursuant to the Second Class Township Code (53 P.S. §65101, et seq.) that Ordinance No. 9-92 is hereby amended as follows:

A. The Township Code of Ordinances, Article II, Nonuniformed Employees Pension Plan, Section 32-16.F. shall be amended, as previously set forth in Resolution Number 26-01, to reduce the vesting schedule to five (5) years.

B. This Ordinance shall take effect immediately.

**AN ORDINANCE OF THE TOWNSHIP OF CECIL, WASHINGTON COUNTY,
PENNSYLVANIA, AMENDING VESTING PROVISIONS OF THE NONUNIFORMED
EMPLOYEES PENSION PLAN, ADOPTED DECEMBER 30, 1992 BY ORDINANCE
NUMBER 9-92, AS AMENDED BY RESOLUTION NUMBER 26-01.**

The Township of Cecil ("Township") has enacted the Nonuniformed Employees Pension Plan ("Plan").

By Resolution Number 26-01, the vesting schedule was reduced to five (5) years.

The Auditor General's Compliance Audit of the Plan ("Compliance Audit"), dated March 2020, found that Ordinance Number 9-92 was improperly amended by resolution and should have been amended by Ordinance.


Therefore, to comply with the findings of the Compliance Audit, the Township seeks to amend by Ordinance the Plan as follows:


A. The Township Code of Ordinances, Article II, Nonuniformed Employees Pension Plan, Section 32-16.F. shall be amended, as previously set forth in Resolution Number 26-01, to reduce the vesting schedule to five (5) years.

B. This Ordinance shall take effect immediately.
