### LOCAL LAW NO. 6-2023

#### A Local Law Amending Chapter 142 of the Village of Chittenango Code to Designate North Street as a One-Way Street

Be it enacted by the Village of Chittenango, as follows:

#### Section I

In accordance with Section 142 – 5 of the Village of Chittenango Code, Section 142 – 29 of the Code titled “Schedule II: One-Way Streets,” is hereby amended to designate a portion of North Street as one-way as follows:

<u>Name of Street</u>	<u>Direction of Travel</u>	<u>Limits</u>
North Street	South	From Russell Street to Arch Street

#### Section II

This Local Law shall take effect upon its filing with the New York Secretary of State.


