VILLAGE OF CHITTENANGO LOCAL LAW NO. 2 OF 2023

A LOCAL LAW AUTHORIZING THE PUBLIC BODIES OF THE VILLAGE OF CHITTENANGO TO USE VIDEOCONFERENCING TECHNOLOGY TO PARTICIPATE IN PUBLIC MEETINGS

Be it enacted by the Village Board of Trustees of the Village of Chittenango, as follows:

SECTION 1. INTENT.

It is the intent of this Local Law to give the Village of Chittenango's public bodies, as that term is defined in Public Officers Law § 102, the authority to participate in meetings via videoconference in a manner consistent with the Village's videoconferencing policy and the authority granted in Public Officers Law § 103-a.

SECTION 2. AUTHORITY.

This Local Law is adopted pursuant to Public Officers Law § 103-a which expressly authorizes the Village Board of Trustees to adopt a local law giving the public bodies of the Village of Chittenango the authority to participate in meetings via videoconference from locations not accessible to the public so long as a quorum of the public body participates from locations where the public may be physically present and other conditions are met. This Local Law is also enacted pursuant to the New York State Constitution and New York Municipal Home Rule Law § 10.

SECTION 3. VIDEOCONFERENCING FOR PUBLIC MEETINGS.

The Village Board of Trustees of the Village of Chittenango hereby amends Chapter 3A of the Village of Chittenango Village Code to create a new Section 3A-3, to read, in its entirety, as follows:

"§3A-3 Videoconferencing for public meetings.

The Board of Trustees of the Village of Chittenango does hereby authorize all members of the public bodies of the Village of Chittenango to participate in meetings using videoconferencing technology in a manner consistent with Public Officers Law § 103-a and the Village's videoconferencing policy, titled "Policy and Procedures for Village of Chittenango Public Body Member Videoconferencing Pursuant to Public Officers Law § 103-a," as adopted by resolution of the Village Board of Trustees."

SECTION 4. SEVERABILITY.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm, or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

SECTION 5. EFFECTIVE DATE.

This Local Law shall take effect immediately upon filing with the Secretary of State.
