Section 36-1 Commission established; This Town Board hereby establishes a highway safety committee to be known as the "Traffic Safety Commission," pursuant to the provisions of § 333 of the Executive Law.

Section 36-2 Authorization to appoint; powers of committees. For the purpose of promoting the safety, health and general welfare of the residents and owners of property in the Town of Cheektowaga, the Town Board of said Town shall be authorized to appoint a Traffic Safety Commission, and such other advisory committees as the Town Board shall deem appropriate to act in an advisory capacity to the Town Board and to serve without compensation. Such advisory committees shall have no powers other than advisors.

Section 36-3 Composition of Traffic Safety Commission; Term of Members; Election of Chairman

A. The Traffic Safety Commission (TSC) shall consist of no more than seven (7) voting members nominated by a Town Board member and approved by a majority vote of the Town Board. Members of the TSC shall be appointed for term of three (3) years from and after the expiration of the terms of their predecessors in office. Terms shall commence upon appointment of the Town Board and shall expire on the 31st day of December in the year their term expires.

- **B.** If a vacancy shall occur otherwise than by expiration of term, it shall be filled by the Town Board by appointment for the unexpired term.
- C. The members of the Traffic Safety Commission shall elect a Chairperson annually from their members.

Section 36-4 Qualifications

- A. Each member must possess a minimum of 5 Years of Experience as:
 - a. Current or Retired Police Officer; or
 - b Current or former Department of Transportation (DOT) employment; or
 - c Current or former Highway Department employment; or
 - d Current or former employment/experience in similar Traffic, Transportation; or
 - e. Engineering field,
