RESOLUTION 2024-503

Amend Rental Rates and Fee Schedule for Towing of Vehicles

WHEREAS, by resolution dated April 18, 2016, this Town Board adopted Local Law No. 3 of the Year 2016, entitled "A Local Law to Amend a Local Law Relating to Vehicles, Removal and Storage"; AND

WHEREAS, pursuant to said local law, Section 241-3.1.B of the Town Code was amended to provide that rental rates would be established from time to time by Town Board resolution; AND

WHEREAS, Section 241-15 was also amended to provide that the Fee schedule (fees to be charged by authorized Town towers) would also be established by the Town Board by resolution from time to time, NOW, THEREFORE, BE IT

RESOLVED, that the rental rates to be established under Section 241-3.1.B. of the Town Code and fee schedules to be established under Section 241-15 be and hereby are amended as follows:
