## ORDINANCE #24-08

### AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION OF \$150,000.00 FOR THE PREPARATION OF A MASTER PLAN

**WHEREAS**, the Local Budget Law, N.J.S.A. 40A:4-53, provides that a municipality may adopt an ordinance authorizing a special emergency appropriation for, among other things, the engagement of consultants for the preparation of a master plan or plans, when required to conform to the planning law of the State; and

**WHEREAS**, in accordance with N.J.S.A. 40A:4-53, the Borough Council wishes to authorize a special emergency appropriation for the engagement of consultants for the preparation of a master plan.

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Chatham, County of Morris, State of New Jersey as follows:

1. A special emergency appropriation in the amount of \$150,000.00 is hereby authorized and made for the purpose of the preparation of a master plan
2. The Borough hereby authorizes the Chief Financial Officer to finance such appropriations from either the surplus funds available or by issuing special emergency notes from time to time in accordance with the provisions of N.J.S.A. 40A:4-55.
3. Said special emergency appropriations, whether financed from surplus funds or the issuance of special emergency notes, shall be provided for in full in the budgets of the next succeeding years by the inclusion of not less than one-fifth of each total amount in each of the next succeeding annual budgets.
4. In accordance with the requirements of N.J.S.A. 40A:4-53, a copy of this ordinance as adopted shall be filed with the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey.
5. This ordinance shall take effect as provided by law.

**NOW BE IT FURTHER RESOLVED**, that all other Borough officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.
