AMENDMENT TO CHAPTER 124, WATER, ARTICLE I, § 124-1. AND ARTICLE III, § 124-36. OF THE CODE OF THE TOWN OF CHAMPLAIN

SECTION 1: TITLE.

This local law, No.<u>3</u> of 2024, shall be known and cited as an amendment to "Water Code Chapter 124" Article I, adopted under Local Law No. 1 of 1995, and amended under Local Law No. 2 of 2024, and Article III, adopted under Local Law No. 1 of 2016 and amended under Local Law No. 2 of 2024.

SECTION 2: AUTHORITY.

This local law is adopted pursuant to the authority and power granted by Articles 2 and 3 of the New York State Municipal Home Rule Law, and by Article 2 of the New York State Statute of Local Governments.

SECTION 3: ARTICLE I, WATER SERVICE, § 124-1.

Chapter 124 of the Town of Champlain, entitled "Water" is hereby amended to add the following definitions and amendments to the terminology that is used throughout Article I, Water Service to provide clarification to § 124-1, Definitions as follows:

§124-1: Definitions.

Agent – An authorized and qualified employee or official appointed by the Town to carry out the duties and functions within the water district defined herein on behalf of the Town.

Contractor – Any person or entity that contracts with the Town for work or improvements in the operation or maintenance to be performed within the water district.

Town – The Town of Champlain, Clinton County, State of New York and may, as appropriate, mean the Town of Champlain acting on behalf of a district.

Town Board – Town Board of the Town of Champlain, Clinton County, New York, acting on behalf of the town or on behalf of a district, as appropriate.

Water District – Town of Champlain, Clinton County, New York water district providing water service, including water districts as described in Chapter 124.

Contractor – Any person or entity that contracts with the Town for work or improvements in the operation or maintenance to be performed within the water district.
