Striking from Chapter 32, Article I §1-A "six"

And insert in place thereof "four"

The revised Chapter 32, Article I §1-A will read:

The general charge of the financial interest of the City shall be in a standing Committee on Finance, which shall consist of the President of the City Council and four members of the Council appointed by the President. Said Committee shall annually in the months of November and December meet to compile recommendations for the City Council budget for the ensuing municipal year, which recommendations shall be passed upon by the City Council for referral to the Mayor.
