## CERTIFICATE OF VOTE ARTICLE 19

Rezoning Parcel 113-397-7 from OC to RC

2017 Fall Annual Town Meeting Second Session – Thursday, October 19, 2017

I, Patricia E. Dzuris, Town Clerk of Chelmsford, Massachusetts, do hereby certify the following vote taken under Article 19 at the second session of the 2017 Fall Annual Town Meeting held at the Chelmsford Senior Center 75 Groton Road, Chelmsford, MA 01863. The meeting was called to order at 7:30 PM by Moderator Jon H. Kurland. There were 104 members present which satisfied a quorum requirement of 82.

<b>ARTICLE 19.</b> To see if the Town will vote to amend Section 195-3 of the Cheimsford Zonning Bylaw
by rezoning from a "OC" Open Space to "RC" General Residence, a parcel of land, containing a total of
107.193 square feet of land, more or less, located off of Mill Road in Chelmsford, which parcel is shown
as Lot 2 on a plan entitled Plan of Land in Chelmsford, Massachusetts, Prepared for Russell Mill Swim
and Tennis Club, Scale 1"=40'. dated, 2017, Prepared by Stamski and McNary, Inc. which
plan is recorded with the Middlesex North Registry of Deeds in Plan Book, Plan and
which parcel is a portion of the property shown as Assessors' Map 113, Block 397, Lot 7 and constitutes
a portion of the premises described in deeds recorded in the Middlesex North Registry of Deeds in Book
1258, Page 174; and Book 1653, Page 25; or act in relation thereto.
