## CERTIFICATE OF VOTE ARTICLE 19 OCTOBER 15, 2012 FALL ANNUAL TOWN MEETING SECOND SESSION THURSDAY, OCTOBER 18, 2012

I, Onorina Z. Maloney, Town Clerk of Chelmsford, Massachusetts do hereby certify the following vote taken under Article19 at the second session of the October 15, 2012 Annual Fall Town Meeting held at the Chelmsford Senior Center 75 Groton Road, North Chelmsford. The meeting was called to order at 7:40 pm by Moderator Richard DeFreitas. There were 129 Town Meeting Representatives in attendance which satisfied the quorum of 82.

**ARTICLE 19.** To see if the Town will vote to amend the Town Code, Chapter 195, "Zoning Bylaw", for purposes of amending section 195-104, "Site Plan Review", sub-section E (4), by deleting the language shown in strikethrough and adding the language shown as underlining, as follows:

195-104.E.(4) The site plan shall be accompanied by drainage calculations <u>stamped</u> by a registered professional engineer. <u>The stormwater system</u> <u>Storm drainage</u> design <u>shall must</u> conform to <u>the current</u> <u>Mass Department of Environmental Protection Stormwater Policy</u>. See section 2.6 of the Planning <u>Board Site Plan and Special Permit Regulations for further criteria</u>. <u>Town of Chelmsford subdivision</u> regulations.
