**LOCAL LAW NO. 1 OF THE YEAR 2023**  
**VILLAGE OF CLINTON, COUNTY OF ONEIDA**

**A local law authorizing a property tax levy in excess of the  
limit established in General Municipal Law § 3-c**

**BE IT ENACTED** by the Board of Trustees of the Village  
of Clinton as follows:

**SECTION 1. Legislative Intent**

It is the intent of this local law to allow the Village of Clinton to adopt a budget for the fiscal year commencing June 1, 2023 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

**SECTION 2. Authority**

This local law is adopted pursuant to subdivision 5 of the General Municipal Law § 3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

**SECTION 3. Tax Levy Limit Override**

The Board of Trustees of the Village of Clinton, County of Oneida, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2023 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law 3-c.

**SECTION 4. Severability**

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence,
