**RE: AMENDMENT OF CHAPTER 211 TRAFFIC &
VEHICLES ORDINANCE OF THE CLAY CODE**

At a Regular Meeting of the Town Board of the Town of Clay, County of Onondaga, State of New York, held at the Town Hall of the Town of Clay, located at 4401 State Route 31, Clay, New York, on the **6th** day of **May 2024**, at **7:30 P.M.**, local time.

The following resolution was moved, seconded, and passed, to wit:

WHEREAS, it has been duly presented that the Town Board of the Town of Clay designate and provide for the amendment of the Traffic & Vehicles Ordinance, Chapter 211, Section 211-12, Schedule IX, (§211-42) to designate and provide for three (3) stop signs to be installed at the intersection of Dell Center Drive at Hallston Drive, to make a three-way stop; a “No Outlet” sign; and Speed Limit Signs; and the installation of the necessary signs therefore; and

WHEREAS, the Town Board of the Town of Clay passed a resolution on **April 15, 2024** calling a public hearing for **May 6, 2024**, commencing at **7:44 P.M.**, local time, which public hearing was opened, heard at the Town Hall located at 4401 New York State Route 31, Clay, New York, to consider the amendment of Chapter 211, Section 211-12, Schedule IX (§211-42) of the “Traffic & Vehicles Ordinance” of the Clay code, to provide for such signs therefore; and

WHEREAS, the Town Board of the Town of Clay has considered the evidence presented on the subject on **May 6, 2024**, and after having given due consideration thereto have determined that the proposed amendment be limited to designate and provide for three (3) stop signs to be installed at the intersection of Dell Center Drive at Hallston Drive, to make a three-way stop; a “No Outlet” sign; and Speed Limit Signs; and the installation of the necessary signs therefore; and

NOW, THEREFORE, be it

RESOLVED AND ORDERED, that Chapter 211, Section 211-12, Schedule IX (§211-42) of the “Traffic and Vehicles Ordinance” of the Clay Code be and the same is hereby amended by designating for three (3) stop signs to be installed of Dell Center Drive at Hallston Drive, to make a three-way stop; a “No Outlet” sign; and Speed Limit Signs; and the installation of the necessary signs therefore.


