**AN ORDINANCE TO AMEND CHAPTER 347, SECTION 347-60 OF THE CODE OF THE TOWNSHIP OF CLARK REGULATING PARKING, ENTITLED "MUNICIPAL PROPERTY AND BOARD OF EDUCATION PROPERTY" TO ADD A NEW SECTION 347-60A.(5) TO PERMIT THREE-HOUR PARKING ON A PORTION OF THE PARKING LOT AT THE MUNICIPAL BUILDING.**

**BE IT ORDAINED** by the Governing Body of the Township of Clark that Chapter 347, Section 347-60 of the Code of the Township of Clark regulating parking, entitled "Municipal Property and Board of Education Property" is hereby amended to add a new Section 347-60A.(5) to permit three-hour parking on a portion of the parking lot at the Municipal Building; and

**WHEREAS**, the Governing Body of the Township of Clark wishes to amend the aforesaid Ordinance through the exercise of the police power to regulate the use of public property.

**NOW, THEREFORE, BE IT ORDAINED** as follows:

**Section 1:** Section 347-60A of the Code of the Township of Clark is hereby amended to add a new Section 347-60A.(5) as follows:

Notwithstanding Sections 347-60A(1) to (4), parking shall be permitted on a portion of the parking lot at the Municipal Building, 430 Westfield Avenue, Clark, New Jersey, on those twenty (20) designated parking spaces adjacent to the basketball courts starting sixty-five (65) feet from the south west center entrance across from 443 Westfield Avenue, Monday through Friday for a period of three-hours. All vehicles exceeding this three-hour limit in this area shall be in violation of this Section 347-60A.(5) and subject to the penalties set forth in Sections 347-6 and 347-60A.(4)(b).

**Section 2:** In all other respects Section 347-60 is hereby ratified, restated and reconfirmed.

**Section 3:** Any Ordinance or parts thereof inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

**Section 4.** This Ordinance shall take effect upon adoption and upon publication according to law.
