

AN ORDINANCE AUTHORIZING AN AGREEMENT FOR POSTAGE METER LEASING WITH FP MAILING SOLUTIONS, AND AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE SAME ON BEHALF OF THE CITY OF CLARKSON VALLEY, ST. LOUIS COUNTY, MISSOURI.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CLARKSON VALLEY, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:


SECTION 1. The Mayor of the City of Clarkson Valley, Missouri, is hereby authorized and directed to execute for and on behalf of the City of Clarkson Valley, a contract with FP Mailing Solutions, for a postage meter lease, in substantial conformity with the attached Exhibit A.

SECTION 2. The rental fee shall be \$34.95/month, along with any additional fees set forth in Exhibit A.

SECTION 3. The Mayor and City Administrator/Clerk are authorized and directed to pay such sum out of the City Treasury of the City of Clarkson Valley, and the agreement shall be renewed pursuant to the agreement, should the City of Clarkson Valley appropriate the necessary funds.


SECTION 4. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
