Ordinance No. 2023-03
Amendments to the Vehicles and Traffic Ordinance 166

Purpose

The purpose of this Ordinance is to amend the Vehicles and Traffic Ordinance 166-4 Speed Limits for safety purposes.

Revisions/additions to Section 166-4 Speed Limits as follows:

A. Table of Maximum Speed Limit by Name of Street

Brewer Road change - From 35 mph in its entire length.
 To 35 mph from the north end of Brewer at Saxonburg Blvd to the north side of the railroad tracks and 25 mph from the south end of Brewer at Saxonburg Blvd. to the north side of the railroad tracks. (See partial table below.)

Name of Street	Maximum Speed Limit (mph)	Between
Albin Road	35	Entire length
Alderson Road	35	Entire length
Anderson Road	35	Entire length
Brewer Road [Amended 12-28-2023 by Ord. No. 2023-03]	25	From the south end of Brewer at Saxonburg Blvd. to the north side of the railroad tracks
Brewer Road [Amended 12-28-2023 by Ord. No. 2023-03]	35	From the north end of Brewer at Saxonburg Blvd. to the north side of the railroad tracks
Callen Road	35	Entire length

D. After the effective date of any change to or addition of speed limits, the Township shall post with official traffic control devices (speed limit signs) erected in accordance with the Vehicle Code (75 Pa.C.S. § 3362(b)) and applicable regulations of the Pennsylvania Department of Transportation.

E. Any change to or addition of speed limits shall take effect thirty (30) days after the date of its enactment.

F. The provisions of this Ordinance are severable, and in the event that any provision is held invalid, void, illegal, or unconstitutional by any Court, it is the intent of the Board of Supervisors that such determination by the Court shall not affect or render void the remaining provisions of this Ordinance. It is the declared intent of the Board of Supervisors that this Ordinance would have been enacted if any provision subsequently declared to be void, invalid, illegal, or unconstitutional had not been included at the time of enactment.




