ORDINANCE 2023-09

**ORDINANCE ABOLISHING §BH1 ET. SEQ., BOARD OF HEALTH, OF THE
REVISED GENERAL ORDINANCE OF THE BOROUGH OF CLIFFSIDE PARK**

WHEREAS, the Council has, pursuant to Ordinance 2022-02, abolished the Office of the Board of Health; and

WHEREAS, the Council, pursuant to Ordinance 2022-02, created the Board of Health Commission; and

WHEREAS, the Council has reviewed its Ordinance regarding the creation and duties of the Board of Health Commission and has determined that in order to effectively serve the Borough's Residents, all services previously undertaken by the Board of Health Commission can be effectively outsourced; and

NOW, THEREFORE, BE IT ORDAINED that the Council does hereby abolish the Board of Health Commission; and

BE IT FURTHER ORDAINED, that the following Ordinances are rescinded in their entirety:

BE IT FURTHER ORDAINED, that any reference or obligations in the General Ordinances of the Borough of Cliffside Park, to the Board of Health or Board of Health Commission, is hereby rescinded in its entirety.

SEVERABILITY. If the provisions of any article, section, subsection, paragraph, subdivision, or clause of this ordinance shall be judged invalid in whole or in part or as applied to any particular circumstance or individual by a court of competent jurisdiction, such order of judgment shall not effect or invalidate the remainder of any article, section, subsection, paragraph, subdivision, or clause of this ordinance.

REPEALER. All ordinances or parts of ordinances inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistencies only.

EFFECTIVE DATE. This ordinance shall take effect immediately upon final passage and publication as required by law.
