

ORDINANCE NO. 519**AN ORDINANCE OF THE CITY OF CLARENDON, TEXAS APPROVING AND ADOPTING REGULATIONS FOR CURFEW HOUR(S) FOR CITY PARK(S) AND, PROVIDING SEVERABILITY; AND, PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the City of Clarendon is a Type A General Law Municipality; and

WHEREAS, the City Council of the City of Clarendon has adopted and established curfew hour(s) for the City Park(s) set forth in the City of Clarendon Code of Ordinances.

WHEREAS, the City Council has determined that it is in the best interest of the health, safety and general welfare of the citizens of the City of Clarendon to add this regulation; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLARENDON, TEXAS, THAT:

SECTION 1. The above recitals are hereby found to be true and correct and incorporated herein for all purposes.

SECTION 2. The City of Clarendon Code Of Ordinances is hereby added to adopt curfew hour(s) for city park(s) within the City of Clarendon, Texas, as set forth in Exhibit "A", attached hereto and incorporated herein by reference for all purposes.

SECTION 3. The addition will apply to all use of public parks and recreation areas within the corporate limits.

SECTION 4. REPEAL OF CONFLICTING ORDINANCES. All provisions of the Code of Ordinances of the City of Clarendon, Texas, in conflict with the provisions of this Ordinance be, and the same are hereby, repealed, and all other provisions not in conflict with the provisions of this Ordinance shall remain in full force and effect.


SECTION 5. SEVERABILITY. If any section, subsection, clause, phrase, or provision of this Ordinance is held unconstitutional or void by a court of competent jurisdiction, the remainder of the Ordinance shall continue in effect as if the invalid portion had never been included.

SECTION 6. EFFECTIVE DATE: This Ordinance shall become effective and be in full force and effect, from and after the date of its passage.


