TOWN OF CORNWALL LOCAL LAW NO. 2 OF THE YEAR 2023

A Local Law to amend Chapter 41, "Police Regulations", Article III, "Duties of Members of Police Department", Section 41-20 (Rule 3.12), "Employment Outside Department", to allow part-time police officers employed by the Town to accept additional employment with the police departments of other municipalities.

SECTION 1. PURPOSE

The purpose of this Local Law is to promote the public health, safety and welfare by amending Chapter 41, "Police Regulations", Article III, "Duties of Members of Police Department", Section 41-20 (Rule 3.12), "Employment outside Department", to allow part time police officers employed by the Town to accept additional employment with the police departments of other municipalities.

SECTION 2. MUNICIPAL HOME RULE LAW

This law is adopted pursuant to Municipal Home Rule Law § 10(1)(ii)(a)(1) that grants local governments the authority to enact local laws regarding the public health, safety and welfare. To the extent the provisions of this Local Law are in conflict with State law, the Town Board hereby asserts its intention to supersede same pursuant to the Municipal Home Rule Law.

SECTION 3. AMENDMENT OF THE TOWN CODE

Subsection (A)(2) of Section 41-20 (Rule 3.12), "Employment outside Department" in Article III, "Duties of Members of Police Department", of Town of Cornwall Town Code Chapter 41, "Police Regulations", is hereby repealed and reenacted to provide as follows:

"(2) Outside employment in the private sector security field or employment in another Police Department shall not be authorized, excepting that part time police officers may be permitted to accept additional employment in the police departments of other municipalities."

SECTION 4. EFFECTIVE DATE

This Local Law shall become effective upon filing with the Secretary of State of the State of New York subsequent to having been duly adopted by the Town Board.
