

**CITY OF COATESVILLE  
COUNTY OF CHESTER**

**AN ORDINANCE AMENDING PART II, GENERAL LEGISLATION, CHAPTER 190, SOLID WASTE, PART 1, RECYCLING, ARTICLE I, RECYCLING, §190-4, SEPARATION REQUIREMENTS, SUBSECTION C, COMMERCIAL, INSTITUTIONAL, INDUSTRIAL AND MUNICIPAL ESTABLISHMENTS, OF THE GENERAL LAWS OF THE CITY OF COATESVILLE, PENNSYLVANIA, BY DELETING SUBSECTION C IN ITS ENTIRETY AND REPLACING IT WITH LANGUAGE THAT DIRECTS COMMERCIAL, INSTITUTIONAL, INDUSTRIAL AND MUNICIPAL ESTABLISHMENTS, AND COMMUNITY ACTIVITIES TO SEPARATE RECYCLABLE MATERIALS.**

WHEREAS, the City of Coatesville (hereinafter the “City”) is a Home Rule Municipality operating by means of a home rule charter and the laws of the Commonwealth of Pennsylvania; and

WHEREAS, §2-301.I of the City Charter requires that the City pass an ordinance to amend or repeal any ordinance previously adopted; and

WHEREAS, the City Council of the City of Coatesville desires to amend a certain subsection of §190-4 (Separation requirements) of the Code of the City of Coatesville.

**BE IT HEREBY ENACTED AND ORDAINED** by the City Council of the City of Coatesville, Chester County, Commonwealth of Pennsylvania, that Part II, General Legislation, Chapter 190, Solid Waste, Part 1, Recycling, Article I, Recycling, §190-4, Separation requirements, of the Code of the City of Coatesville, as amended, shall be amended as follows:

**SECTION 1.** Part II, General Legislation, Chapter 190, Solid Waste, Part 1, Recycling, Article I, Recycling, §190-4, Separation requirements, Subsection “C” as amended, shall be deleted in its entirety and shall be replaced to read as follows:

C. Commercial, institutional, industrial and municipal establishments, and community activities.

- 1) Commercial, institutional, industrial and municipal establishments, and community activities are hereby required to separate all recyclable materials as specified by regulation and to store such material until collection. The times, dates and places for collection shall be established by regulations. Such regulations shall schedule a minimum of one day per month for pickup of recyclables from commercial, institutional, industrial and municipal establishments. All commercial, industrial, municipal and institutional establishments, and community activities shall be required to

separate for collection and recycling high-grade office paper, corrugated paper and aluminum cans.

- 2) The City's Recycling Coordinator shall have the authority to verify the appropriateness of each recycling plan for each commercial, institutional, industrial and municipal establishment, and community activity. In addition, anyone who has a food and beverage license must follow the same rules as a commercial or institutional establishment and must also recycle glass bottles and jars (clear, green and brown).
- 3) Verification forms must to returned to the City's Recycling Coordinator annually prior to October 1.

**SECTION 2.** Any and all provisions of any other ordinance which are inconsistent with the provisions of this ordinance are hereby repealed.

**SECTION 3.** If any part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining parts of this ordinance which shall continue to be fully operative as if the unconstitutional, illegal or invalid part had not been enacted.

**SECTION 4.** This Ordinance shall take effect 30 days after publication following final adoption.
