EMERGENCY ORDINANCE 2021-01

AN EMERGENCY ORDINANCE OF THE COTTAGE CITY COMMISSION TO ADOPT A BUDGET AMENDMENT FOR THE 2021-2022 FISCAL YEAR REGARDING FEDERAL ARPA GRANT FUNDS

WHEREAS, under funding administered by the State of Maryland pursuant to the Federal American Rescue Plan Act of 2021 Coronavirus Local Fiscal Recovery Funds (ARPA Funds), every level of government in Maryland will receive funding, regardless of size; and

WHEREAS, Cottage City is expected to receive \$1.1 million in federal ARPA funding which must be obligated by December 31, 2024 and said funds must be expended by December 31, 2026.

WHEREAS, ARPA funds may be utilized by state, county, and municipal governments to respond to and prepare for COVID-19 activities, as well as the replacement of revenues lost as a result of COVID-19 including payroll and covered benefits expenses for public health, healthcare, human services, public safety and similar employees and under the Coronavirus Capital Projects Fund carry out capital projects enabling work, education, and health monitoring, including telehealth options, in response to COVID-19; and

WHEREAS, the Town of Cottage City has received the first tranche of funds in July and the second installment of the Town's disbursement in August 2022, and the town is in the process of making plans regarding the use of the ARPA funds as part of the Town's planning and development process; and

WHEREAS, the Town continues to engage the residents, businesses, and community organizations on the use of the ARPA funds, and all interested persons are encouraged to participate in the planning process, and the Town has encouraged the community to focus on recovery goals during the community engagement process. In order to gain insight from residents to determine community goals and the best application for the funding

WHEREAS, Sections 38, 39, and 40 of the Charter of Cottage City requires the Cottage City Commission to adopt an annual budget containing anticipated revenues and appropriations for public purposes; and

WHEREAS, Section 39 of the Charter requires that the budget shall be prepared and adopted in the form of an ordinance; and

WHEREAS, the Cottage City Commission approved a budget for the fiscal year beginning July 1, 2021, and ending June 30, 2022, containing anticipated revenues and proposed expenditures by Ordinance 2021-02 enacted on or about June 9, 2021; and

WHEREAS, pursuant to Md. Code Ann., LG Article, Section 5-205(b)(4), a municipality may spend money for a purpose different from the purpose for which the money was appropriated or spend money not appropriated at the time of the annual levy if approved by a two-thirds vote of all the individuals elected to the legislative body; and

WHEREAS, the Cottage City Commission desires to amend the FY22 budget to increase ARPA Grant Revenue by \$574,995 and provide for a corresponding increase of Total Expenditures by adding ARPA Fund Grant Expenditures of \$574,995; and

WHEREAS, the Cottage City Commission deems it appropriate to adopt this amendatory budget ordinance as an emergency ordinance so that it can take effect immediately.

NOW, THEREFORE, BE IT ORDAINED BY THE COTTAGE CITY COMMISSION, in special or regular session assembled, that the Town of Cottage City Budget containing anticipated revenues and proposed expenditures that is indicated below, is hereby revised, amended and adopted for fiscal year 2022, beginning July 1, 2021, and ending June 30, 2022, as indicated hereinbelow.

AND BE IT FURTHER ORDAINED that all budget amendments transferring monies between major revenue funds, line items, classifications and/or major appropriations as reflected in this FY 2022 Budget Ordinance shall be submitted to the Cottage City Commission for approval, from time to time, by ordinance; whereas, minor budget changes or amendments occurring from time to time within certain specified sub-categories or the various detailed items not reflected herein above shall only be shown in the Detailed Budget to be approved from time to time by the Town Manager subject to review and approval by the Cottage City Commission as recorded in the journal of its proceedings.

AND BE IT FURTHER ORDAINED that this Emergency Ordinance shall take effect immediately, and that a fair summary shall be published at least once within ten days after the date of passage in a newspaper or newspapers having general circulation in Cottage City.
