#### ORDINANCE NO. 392

# AN ORDINANCE OF CONCORD TOWNSHIP AMENDING ORDINANCE NO. 365 OF 2015, AS AMENDED, BY AMENDING THE CODE OF THE TOWNSHIP OF CONCORD BY AMENDING CHAPTER 53, MEMBERSHIP, TO DECREASE THE NUMBER OF PLANNING COMMISSION MEMBERS FROM NINE MEMBERS TO SEVEN MEMBERS.

The Township Council of Concord Township, Delaware County, Pennsylvania does hereby ENACT and ORDAIN that Chapter 53 of the Code of the Township, as amended by Ordinance No 365, enacted July 7, 2015, is amended as follows:

## SECTION I. Chapter 53. Membership

SECTION 53-2. The Code of the Township is hereby amended by amending the first sentence of Section 53-2. Membership; appointment; terms of office to read as follows:

Said Commission shall be composed of seven (7) citizens of the Township of Concord, who shall be appointed by Township Council Members and shall receive compensation for attending hearings and for the performance of their duties at a rate not to exceed \$1,200 per annum, payable quarterly at a rate of \$100/month, or at such compensation as may be established by the Township Council Members by Resolution.

**SECTION II**. In all other respects, Ordinance No. 365 of the Township of Concord enacted on July 7, 2015, which amended Ordinance No. 56 of the Township of Concord, enacted on July 5, 1970, which amended Ordinance No. 38 enacted on April 11, 1966, except as changed by this Ordinance, is hereby ratified and confirmed.

#### SECTION III. REPEALER.

All Township ordinances and parts of ordinances inconsistent with the provisions hereof, are hereby repealed and rescinded to the extent of any inconsistency or conflict.

## SECTION IV. SEVERABILITY.

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any remaining provisions, sentences, clauses, sections, or parts of this Ordinance. It is hereby declared as the intent of the Council of Concord Township that such remainder shall be and shall remain in full force and effect.

# SECTION V. EFFECTIVE DATE.

This Ordinance shall take effect five (5) days after the date of its enactment by the Council of Concord Township.
